1. SHARE CAPITAL

As at the Latest Practicable Date, the issued and fully paid share capital of the Company comprised 97,000,000 Shares.

Subject to the passing of the Repurchase Resolution and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Proposal to repurchase a maximum of 9,700,000 Shares, during the period from the date on which such resolution is passed until the date of (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Bye-laws or any applicable laws to be held; or (iii) the revocation, variation or renewal of the repurchase mandate by an ordinary resolution of the Shareholders in general meeting, whichever occurs first.

2. REASON FOR REPURCHASE

The Directors believe that the Repurchase Proposal is in the best interests of the Company and its Shareholders. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets value and/or earnings per Share of the Company and will only be made when the Directors believe that such a repurchase will benefit the Company and its Shareholders.

3. FUNDING OF REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Bye-laws, the Listing Rules and the laws of Bermuda. The Company is empowered by its Bye-laws to purchase its Shares. - 3. With regard to item 2 in this notice, the Board proposes that the retiring directors, Mr. NGAI Wah Sang and Mr. WANG Daming be re-elected as directors of the Company. Details of Mr. NGAI Wah Sang and Mr. WANG Daming are set out in the Appendix II to the circular to shareholders of the Company dated 13 April 2015.
- 4. A circular containing an explanatory statement as required by the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited in connection with the proposed share repurchase mandate under the resolution as set out in item 4 above will be despatched to shareholders of the Company together with the 2014 Annual Report of the Company.
