Reference is made to the announcement of Earnest Investments Holdings Limited (the “**Company**”) dated 31 July 2012 (the “**Announcement**”) in relation to the past continuing connected transactions of the Company and the announcement of the Company dated 20 August 2012 (the “**Further Announcement**”) in relation to the delay in despatch of the Circular. Unless otherwise stated, capitalised terms used herein shall bear the same meanings as those defined in the Announcement and the Further Announcement.
